This agreement ("Agreement") is entered into on this **25.12.2023** by and between the following entities:

Hereinafter collectively referred to as the "Parties."

Background:

The Parties, recognizing the benefits of collaboration in the field of education, research, and technology, hereby agree to establish HEIn4 Virtual Factory Learning Labs International Network as a focal point of collaboration in the Industry 4.0 context and to facilitate joint initiatives and projects.

Terms and Conditions:

- Purpose: The purpose of the HEIn4 Laboratory Network is to foster collaboration among the participating institutions in the areas of industry 4.0, research, innovation, and academic development.
- Collaborative Initiatives: The Parties agree to explore and implement collaborative initiatives, including joint research projects, exchange programs for faculty and students, and the sharing of laboratory facilities and resources.
- 3. **Resource Sharing:** The Parties may share laboratory equipment, research materials, and other resources for the mutual benefit of all participating institutions.
- Intellectual Property: Intellectual property developed as a result of joint initiatives will be governed by separate agreements to be negotiated and agreed upon by the Parties involved.





- 5. **Financial Arrangements:** The Parties will determine financial responsibilities for joint projects and initiatives on a case-by-case basis through mutual agreement.
- Duration: This Agreement shall be effective upon the date of execution by all Parties and shall remain in force for an initial term of 5 years, with the option for renewal by mutual consent.
- 7. **Termination:** Either Party may terminate this Agreement with written notice to the other Parties at least 6 months prior to the intended date of termination.
